Conservation Policy Program: At the state level, MCVEF has a robust public policy and public education program related to public education and building support for policies to be pursued by the 2019 Montana State Legislature, including policy accountability and pre-session work.

As the facilitator of the Conservation Working Group (CWG), MCVEF worked with over 20 state conservation partners to create a policy agenda for the 2019 legislative session which includes three proactive bills focused on providing energy investment opportunities through commercial Property Assessed Clean Energy, reforming the Public Service Commission procedures to provide more transparency and investing in Montana's state parks and trails through a new funding mechanism via an additional voluntary vehicle registration fee.
